Current Financial Situation

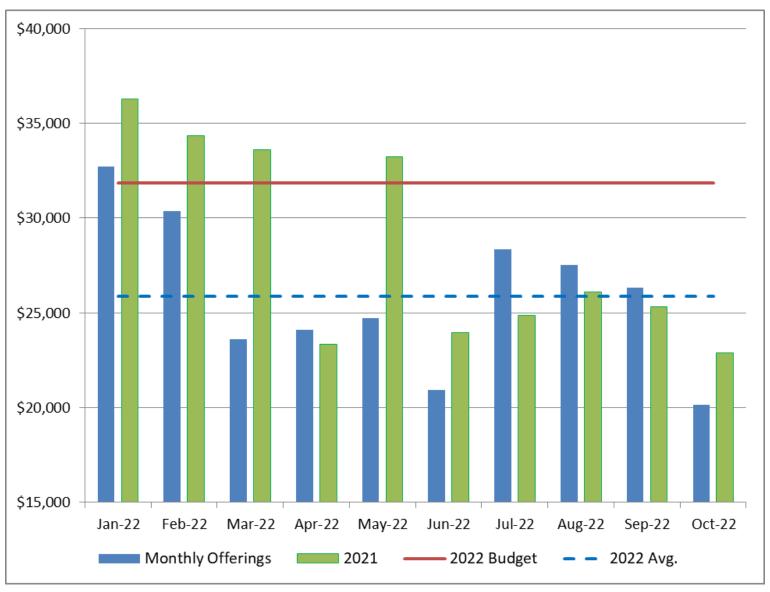
End of October 2022

2023 Budget Notes

- The budget set by the leadership of First Baptist is our "best guess" at what next year has in store
- Overall expenses for 2023 have been slightly increased from the 2022 budget – Personnel, Property, Admin
- The transfers to the Restricted Reserves
 - Loan payments will continue at \$1000/mo.
 - Transfer to Building Fund will continue \$5,000/yr.
- Balanced budget if income and expenses can be maintained
